### ORDER GRANTING MOTION FOR SECOND EXTENSION OF TIME TO SUBMIT COMPLAINANT'S REBUTTAL PREHEARING EXCHANGE

A Prehearing Order in this matter scheduled the parties' prehearing exchanges, setting a due date of May 9, 2008 for Respondent's prehearing exchange and a due date of May 21, 2008 for Complainant's rebuttal prehearing exchange. On May 15, 2008, upon Motion, Complainant was granted an extension until June 4, 2008 to submit its Rebuttal Prehearing Exchange. On June 2, 2004, Complainant filed a Motion for Second Extension of Time to Submit its Rebuttal Prehearing Exchange (Second Motion).

Grounds stated in the Second Motion are that Complainant has requested additional information regarding Respondent's ability to pay the penalty which it anticipates will not be provided to it until mid-June and that its expert witness will need sufficient time thereafter to review such data and prepare a report with regard thereto. Complainant asserts that the Respondent company, which is acting pro se, does not oppose the Second Motion.

The Second Motion is hereby **GRANTED**. Good cause exists for the granting of the Motion for the reasons stated therein. Further, it is in the interest of the parties and judicial economy for the parties to submit complete and accurate information in their prehearing exchanges particularly wih regard to the calculation of the proposed penalty. In that a hearing in this case has not been scheduled, no prejudice will result from another brief delay.

Accordingly, Complainant shall file its Rebuttal Prehearing Exchange on or before July 10, 2008.
