Joint Status Report and Joint Motion for Extension of ADR

Counsel for Complainant and Respondent hereby submit this Joint Status Report and Joint Motion for Extension of ADR:

1. Counsel for Complainant, the Director, Land and Chemicals Division, Region 5, United States Environmental Protection Agency (U.S. EPA), and Respondent North American EN have reached an agreement in principle with respect to payment of a penalty with regard to the allegations alleged by Complainant in the above-entitled matter and with respect to the terms of payment of such penalty. Respondent will not admit to violations, but will admit to Complainant's jurisdiction in the matter.

2. Counsel for Complainant is engaged in preparing a draft consent order for Respondent's review, to be subsequently entered herein as a final judgment, to reflect that agreement in a standard format. It is the expectation of the parties that the consent order will be completed in final form and receive the necessary approvals from U.S. EPA management and Respondent's principals within the next thirty days.

WHEREFORE, Complainant and Respondent move the Honorable Administrative Law Judge for a thirty-day extension of ADR, which is otherwise scheduled to expire on January 7, 2008. The parties will submit a signed Consent Agreement and Final Order on or before February 6, 2008, or will provide an explanation at that time of the status of the matter.


