On April 25, 2024, the United States Environmental Protection Agency Region 3 ("EPA") and Shifflett's Used Auto Parts ("Respondent") entered into an Administrative Order on Consent, Docket No. CWA-03-2024-0050DN ("the Order"). In accordance with Section VII (Certification of Compliance and Request for Termination Of AOC) of the Order, by letter dated September 23, 2025, Respondent submitted a Certification of Compliance and Request for Termination of the Order for the EPA's review.

Based upon the EPA's review of information, including a construction completion certificate, quarterly progress reports, and updated standard operating procedures, submitted in accordance with the Order, and additional correspondence, the EPA believes that Respondent has adequately complied with all requirements of the Order and is granting Respondent's request for termination of the Order.
