Dear Ms. Smith:

This letter is to inform you that the U.S. Environmental Protection Agency (EPA) is terminating the Administrative Order on Consent (Order), Docket No. CWA-08-2013-0035, issued to Corixa Corporation on September 26, 2013. On January 24, 2021, the EPA issued a Notification of Discharge Requirements to Corixa Corporation, which sets forth specific pretreatment requirements applicable to Corixa's Hamilton, Montana, facility. The Notification of Discharge Requirements includes requirements applicable to Corixa Corporation in the Order, rendering the Order unnecessary.

Please be aware that Corixa Corporation is still required to comply with the Clean Water Act (Act) and its implementing regulations, including those set forth in the Notification of Discharge Requirements. Violations of the Act or its implementing regulations may result in EPA issuing an administrative order for compliance, a court-imposed injunction and/or penalty of up to \$56,460 per day for each violation.
