MOTION FOR EXTENSION OF TIME TO FILE ANSWER

Pursuant to 40 C.F.R. §22.16, Respondent, Tanner Industries, Inc. ("Tanner"), requests that the Presiding Officer grant a thirty (30) day extension of time for Respondent to file an Answer in this proceeding.

Respondent received the Complaint on September 22, 2010. An extension of time to file an answer was granted until May 23, 2011 by Order dated April 7, 2011.

The parties have made progress towards a possible settlement during a meeting that occurred on Friday, October 15, 2010 and in subsequent telephone conversations. The parties have reached an agreement in principle and are currently finalizing a Consent Agreement and Final Order to settle the matter. Accordingly, the parties do not anticipate that any further extensions of time will be necessary. On May 16, 2011, Gregory Dain, EPA Region 1 legal counsel in this proceeding, stated via email that EPA would not oppose this motion.
