INTRODUCTION

This is a civil administrative action brought pursuant to Section 14(a) of the Federal Insecticide, Fungicide, and Rodenticide Act (“FIFRA”), 7 U.S.C. § 136(a), for the assessment of a civil administrative penalty against Logitech, Inc. for the sale and distribution of an unregistered pesticide in violation of Section 12(a)(1)(A) of FIFRA, 7 U.S.C. § 136j(a)(1)(A).


MOTION

U.S. Environmental Protection Agency (“EPA”), Region IX, filed a complaint in the above-captioned matter on September 24, 2010. By an order dated May 4, 2011 (the “Order”), Chief

Administrative Law Judge Susan L. Biro was assigned to this matter. In the Order, Judge Biro directed the parties to engage in a settlement conference on or before May 20, 2011 and file a status report regarding settlement on or before May 27, 2011. The Order also required the filing of Complainant's Initial Prehearing Exchange by June 17, 2011, Respondent's Prehearing Exchange by July 8, 2011, and Complainant's Rebuttal Prehearing Exchange by July 22, 2011.

Due to an accident that occurred on May 2, 2011, EPA's counsel will be out of the office on medical leave until at least June 13, 2011. EPA thus requests that this matter be stayed for a one-month period and the above deadlines be deferred accordingly. Logitech does not oppose this motion.


