

ORDER GRANTING
COMPLAINANT'S MOTION FOR EXTENSION OF TIME

On September 28, 2009, the Court issued a Prehearing Order directing the parties to make their initial prehearing exchanges by Friday, November 20, 2009. On November 18, 2009, Complainant filed a second Motion for Extension of Time,¹ requesting that the Court extend the deadline for the parties to make their initial prehearing exchanges by three weeks to allow time for Complainant's counsel to obtain formal approval from Complainant for withdrawal of the Complaint in this matter.

Upon consideration, the Court grants Complainant's request. Three weeks is a reasonable period of time for Complainant to seek formal approval for withdrawal of the Complaint. Accordingly, the Court extends the deadline for the parties to make their initial prehearing exchanges from November 20 to December 11, 2009.


