STATUS REPORT


1. This Status Report is filed in compliance with the March 25, 2010, Prehearing Order in this matter.

2. The parties have not engaged in settlement negotiations and have not reached settlement of this matter.

3. On March 30, 2010, Complainant's counsel telephoned Respondent's counsel at the number provided in his pleadings and was unsuccessful in reaching a working number. Complainant's counsel then e-mailed Respondent's counsel (1) informing him of the Prehearing Order and timeline for the parties to engage in a settlement conference by April 5, 2010; and (2) suggesting available times for a settlement conference. On April 5, 2010, Respondent's counsel e-mailed Complainant's counsel in response to the earlier email, providing his new telephone number. On April 6, 2010, the parties' counsel conferred by telephone and later that day in response to Respondent's counsel's verbal request for documentation to evaluate the case and advise his client, Complainant's counsel e-mailed Respondent's counsel (1) providing copies of the leases and disclosure statements for the two counts cited in the Complaint; (2) providing a copy of the Penalty Policy; (3) explaining how the penalties cited in the Complaint were calculated; and (4) suggesting an available time for a settlement conference. Respondent's

counsel later that day e-mailed an acknowledgement of receipt of Complainant's e-mail. On April 12, 2010, Respondent's counsel e-mailed Complainant's counsel that he had reviewed the lease documents and was preparing a "more detailed Request for Production of Documents."


