
ORDER ACCEPTING ANSWER

The substantive requirements for an Answer under the regulations are: that it contain an admission or denial of the allegations in the Complaint; that it state any defenses and the basis therefor; and that it state whether a hearing is requested. 40 CFR 22.15(b).

The Answer received in this matter does meet the requirements of the regulation, as stated above, and thus should be accepted for filing as an Answer under 40 CFR 22.15(b).
