Pursuant to the June 6, 2011 Prehearing Order for this matter, the Complainant hereby submits this Status Report on settlement. The Prehearing Order required that the parties engage in a settlement conference on or before June 17, 2011, and file a Status Report regarding the conference and status of settlement on or before June 24, 2011.

After a brief exchange of emails, the parties have reached an agreement in principle, and now only need to finalize and file the Consent Agreement and Final Order ("CAFO"). 
