

Complainant has filed an Agreed Motion to Extend Alternative Dispute Resolution Period in this ADR matter. The initial period for ADR expires July 6, 2009. The parties have reached an agreement in principle, and that EPA intends to promptly draft a Consent Agreement and Final Order (CAFO). An extension of 30 days, or until August 5, 2009, will allow the parties to finalize and exchange the CAFO. Accordingly, the time period provided for ADR is extended to and including August 5, 2009.
