MOTION TO EXTEND TIME TO FILE ANSWER

In support of this Motion to Extend Time to File an Answer, which is made pursuant to 40 CFR 22.16, Respondent states as follows:

1. Respondent and USEPA have scheduled an Informal Settlement Conference for on or about the week of November 5, 2012 to determine if the parties can reach an amicable resolution of the issues raised in the October 1, 2012 Complaint and Notice of Opportunity for Hearing, Docket No.: CAA-02-2012-1220 ("Complaint"), which Complaint was received by Respondent on October 3, 2012.
2. Pursuant to 40 CFR 22.15, the date for Respondent to file an Answer is on or about November 2, 2012.
3. The date for filing an Answer to the Complaint comes before the scheduled Informal Settlement conference, which is expected to be scheduled during the week of November 12, 2012.

4. USEPA has advised, through its Regional Counsel, that, in light of the Informal Settlement Conference, it will not oppose a reasonable extension of time to file an Answer to the Complaint.


RELIEF SOUGHT


