- On December 14, 2010, this Honorable Court ordered that Complainant's Initial Prehearing Exchange be filed by February 28, 2011. Respondent's Prehearing Exchange is due March 28, 2011.
- These exchanges are not necessary since the Parties reached an agreement in principle on February 25, 2011. The agreement is dispositive of all matters asserted in the Complaint.
- 3. The Parties will engage in settlement discussions in order to reach an agreement as to the final language and terms of the Consent Agreement and Final Order

(CA/FO). Once the CA/FO is finalized it will be placed into concurrence, and the fully executed CA/FO will be filed immediately.

- 4. This Motion has been filed today in order to have the Administrative Law Judge, Honorable Barbara A. Gunning, take notice of the agreement reached by the Parties and of the progress made in formalizing this agreement in a fully executed CA/FO, and to request 60 days to file the CA/FO.
- The Parties request the Honorable Presiding Officer to: (1) set aside the Prehearing Exchange schedule and: (2) to impose a 60 days deadline to file the duly executed CA/FO.
- 6. This Motion was discussed today, February 28, 2011, with Francis Torres, Esq., counsel for Respondent, who agreed to the filing of this Joint Motion.
