

Summary

EPA is providing notice of a proposed administrative penalty settlement with Hawaii Fueling Facilities Corporation and Signature Flight Support Corporation (Respondents) for violations of Clean Water Act (CWA) regulations at its bulk fuel storage facility located at 6 Sand Island Access Road, Honolulu, Hawaii. EPA alleges the Respondents violated requirements under 40 Code of Federal Regulations (C.F.R.) Part 112, by failing to provide sufficiently impervious secondary containment and failing to provide secondary containment sized to contain a spill from the single largest container plus freeboard for precipitation.

Pursuant to Section 311(b)(6) of the CWA, 33 U.S.C. § 1321(b)(6), and in accordance with 40 C.F.R. Part 22 (rules of practice for assessing administrative civil penalties), EPA proposes entering into a **Consent Agreement and Final Order** (CA/FO) with Respondents to simultaneously commence and conclude this CWA Class II civil administrative penalty proceeding. Under the proposed CA/FO, Respondents will pay the United States a civil penalty of \$150,000 to resolve this matter.

Description of Business or Activity Conducted by the Respondents:

Respondents operate a bulkfuel storage and distribution terminal facility located at 6 Sand Island Access Road, Honolulu, Hawaii (the Facility). The Facility is subject to certain requirements, including the SPCC Rule and implementing regulations at 40 C.F.R. Part 112.

Summary of Alleged Violations: At the Facility, the Respondents failed to provide sufficiently impervious secondary containment and failed to provide secondary containment sized to contain a spill from the single largest container plus freeboard for precipitation.


Proposed Penalty: \$150,000.
