ORDER OF DESIGNATION

Coughlin, Environmental Protection Agency, Washington, DC, is hereby designated as the Administrative Law Judge to preside in this proceeding under Section 309(g) of the Clean Water Act ("CWA"), 33 U.S.C. §1319(g) and in accordance with the Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties and the Revocation or Suspension of Permits 40 CFR Part 22.

Avenue, N.W., Washington, D.C. 20004. Documents filed electronically should be submitted online using the OALJ E-Filing System.¹


The Regional Hearing Clerk may properly reject any documents that a party attempts to file in the Regional Office while this matter is before the Administrative Law Judge.


