To THE HONORABLE COURT:

On May 30th, 2012, an Order On Showing of Good Cause and Order Scheduling Hearing, was issued by Hon. M. Lisa Buschmann, the Administrative Law Judge, for this matter.

The Order requested that the parties hold a settlement conference and attempt to reach an amicable resolution to this matter. Complainant was order to file a status report regarding such conference and the status of settlement on or before by August 3rd, 2012.

The parties exchanged counteroffers, and have reached a settlement in principle. Complainant is preparing the Consent Agreement and Final Order (CA/FO) that incorporates the terms of the agreement, and expects to forward the CA/FO to respondent's counsel before the end of this week.

On July 27th, 2012, the parties informed Mr. Michael B. Wright, Staff Attorney of the Office of Administrative Law Judges the above information. We informed Mr. Wright that we

expect to have a fully executed CA/FO before the scheduled date for the hearing on this matter, September 18th, 2012. If any situation arises, during the concurrence process, that warrants an extension of time, Complainant will request the extension in a timely manner.
