Introduction: The Presiding Officer requested that the parties' attorneys provide an update on efforts to resolve this matter.

Status: Respondent's attorney stated that the parties have agreed on the cash component of the settlement, indicating that she spoke with the mayor of her client, the Municipality of Culebra and he agreed to accept the most recent offer by EPA. While EPA's attorney is working on the draft Consent Agreement and Final Order (CA/FO), Respondent's attorney is working on the draft of a SEP, based in part on her meetings with engineers and comments made by Complainant's counsel. The parties agreed that the SEP must have a completion date which can be indicated in the CA/FO and Respondent's attorney needs to get an update from the engineers and her client regarding costs, completion date, etc. Complainant's counsel stated that EPA will circulate the draft CA/FO internally for comments and then share the draft with Respondent's

counsel to get their input, and incorporate comments as appropriate. She hopes to have the CA/FO ready for final concurrence and execution shortly

The parties agreed that it was in the best interest of all parties to schedule a follow up status teleconference to apprise the Undersigned of their progress in resolving this matter. In light of the facts set forth herein, the Undersigned issues the following **ORDER**.
