Dear Mr. Ostlund:

On March 22, 2007, the United States Environmental Protection Agency ("EPA") issued an Administrative Order, Docket No. SDWA-08-2007-0039, ordering the Sports Bar Public Water System ("the System") to comply with the Safe Drinking Water Act ("SDWA"), 42 U.S.C. section 300f *et seq.*, and its implementing regulations, the National Primary Drinking Water Regulations ("NPDWRs"), 40 C.F.R. part 141.

Our records indicate that the System is in violation of the Administrative Order ("the Order"). The Order requires the System to:

1. As of the effective date of the Order, comply with the total coliform monitoring requirements as stated in 40 C.F.R. § 141.21 to determine compliance with the total coliform MCL appearing at 40 C.F.R. § 141.63, and report analytical results to EPA within the first 10 days following the month in which sample results are received, as required by 40 C.F.R. § 141.31(a).

EPA has not received total coliform sample results for the second quarter (April through June) of 2007. If monitoring was completed, you must send the results to EPA immediately.

2. Upon the effective date of this Order, comply with 40 C.F.R. § 141.21(g)(2) by reporting any failure to comply with coliform monitoring requirements under 40 C.F.R. § 141.21 to EPA within 10 days after the System discovers the violation.

The total coliform monitoring violation for the second quarter of 2007 was not reported to EPA.

EPA is considering additional enforcement action as a result of your non-compliance with the Order. Violating an Administrative Order may lead to (1) a penalty of up to \$32,500 per day per violation of the Order, and/or (2) a court injunction ordering compliance.

In addition, EPA is sending under separate cover a second Administrative Order that addresses violations not included in the March 22, 2007, Order.
