The EPA has decided to close the Administrative Order (Order) regarding the public water system specified in the subject line.

The Town of Hulett public water system (WY5600026) is required to comply with the National Primary Drinking Water Regulations (drinking water regulations), 40 C.F.R. part 141. Violation of the drinking water regulations may result in a court-imposed injunction and/or penalties.

The EPA's record reflects that Roberts Trailer Park PWS failed to submit a copy of the lead and copper consumer notice and certification to the EPA within 90 calendar days following the end of the corresponding 2019 and 2020, monitoring periods. Attached find the lead and copper results for the outstanding 2019 and 2020 LCCN violations for Roberts Trailer Park and consumer notice template. In order to correct those violations, you must deliver a consumer notice of the tap monitoring results to the persons served at each sampled site, in accordance with 40 C.F.R. § 141.85(d). and submit to the EPA a sample copy of the consumer notification along with a certification that the notification has been distributed, in accordance with 40 C.F.R. § 141.90(f)(3). These violations will remain open until these documents are received by EPA.
