## JOINT MOTION FOR EXTENSION OF TIME FOR RESPONDENT TO FILE ANSWER

Pursuant to 40 C.F.R. §22.7(b), the Complainant and Respondent ("Parties") respectfully request a 30-day extension (until April 23, 2008) for Respondent to file a written Answer to the Complainant's Administrative Complaint. As grounds for this motion, the Parties state as follows:

- 1. On January 17, 2008, Complainant filed its Complaint in this action;
- 2. On January 17, 2008, Respondent spoke with Complainant and expressed its willingness to achieve an expeditious settlement of this matter;
- 3. Based upon this representation, the Parties filed a Joint Motion to Extend the Time for Respondent to file its Answer until March 24, 2008, and the Hearing Officer granted this Motion;
- 4. The Parties began settlement negotiations on March 5, 2008 and remain actively involved in discussions;
