The City of Helena, Respondent in this matter, has filed a Motion to Stay Proceedings, citing a lawsuit filed on November 16, 2021, in the United States District Court for the District of Montana. The lawsuit is a challenge to a "Final Determination" by the United States Environmental Protection Agency, which is indicated as having the same Docket Number as this administrative penalty proceeding. The Hon. Katherin Hall, Regional Judicial Officer for EPA Region 8, has issued an order directing Complainant to file a response to the Motion to Stay Proceedings no later than January 26, 2022.

Complainant's counsel first learned of the lawsuit having been filed when Complainant's counsel was copied on a January 11, 2022, email from Respondent's counsel to the Regional Hearing Clerk. The email transmitted the Respondent's Motion to Stay Proceedings. The complaint in the federal lawsuit was an attachment to the motion. The complaint had not been served on the United States at the time. It has since been served on the United States. The answer of the United States is due by March 14, 2022.

Accordingly, Complainant requests a stay in this matter until March 28, 2022, to provide Complainant an opportunity to confer with the United States Department of Justice. If a stay is granted until that date, Complainant will file a status report with this tribunal no later than March 28, 2022.
