**Introduction:** The Presiding Officer established that the purpose of the teleconference was to assess the status of this matter.

**Status:** Complainant's attorney explained that Respondent had signed the Consent Agreement and Final Order on August 25, 2014, and same was received by EPA on August 26, 2014. The CA/FO is currently circulating in EPA for signature. Both parties expect the CA/FO to be finalized and filed in the near future.

Although the filing of the CA/FO settling this matter appears to be imminent, the Undersigned thought that it was in the best interest of both parties to schedule a follow up status teleconference in case any issues arose regarding final execution of the CA/FO.
