

**ORDER GRANTING JOINT MOTION REQUESTING SECOND EXTENSION OF
ALTERNATIVE DISPUTE RESOLUTION PROCESS**

The Alternative Dispute Resolution (“ADR”) process currently expires February 2, 2011. By a joint motion, dated January 27, 2011, the parties represented that they are in serious negotiations to settle this proceeding. Specifically, the parties indicate that a conceptual supplemental environmental project (“SEP”) has been presented and preliminarily endorsed, and that the cash component of the settlement will be negotiated upon further definition of the SEP. The parties have requested a 30-day extension of the ADR process to reach settlement. Good cause having been shown, the motion is granted and the ADR process in this matter is extended to and including **March 4, 2011**.
