
**ORDER GRANTING ON JOINT
MOTION TO AMEND
ADMINISTRATIVE COMPLAINT AND
CONSENT AGREEMENT**

On January 13, 2012, the parties filed a Joint Motion to Amend Administrative Complaint and Consent Agreement. The Motion requests, pursuant to Paragraph F.13 of the Agreement, that the Complaint and Consent Agreement be amended to include a Revised Appendix A, Tables A-3 and A-4 to the Agreement.

The parties request that Appendix A be amended to change one (1) source in Table A-3 and three (3) additional sources in Table A-4. Specifically, the Revised Table A-3 now includes a source named "Hans" that replaces the source named "Bugle/Trumpet," which has been removed. The revised Table A-4 now includes the sources named "Coyote/Prairie Dog," "Emerald/Bradfield," and "Atlas/Calypso," replacing the respective sources "Badger/Mink," "Air/Carbon/Earth/Sky," and "Mustang/Pinto," which have been removed.

The court hereby approves the Motion to Amend to include the Revised Appendix A, Tables A-3 and A-4 based on the terms of the Complaint and Consent Agreement and for good cause shown pursuant to 40 C.F.R. §§22.14(c) 22.16(c) and 22.18(b)(2). The Respondent is hereby **ORDERED** to comply with all the terms of the Consent Agreement which was effective August 29, 2011 by Final Order.


