CONSENT AGREEMENT

I. Statutory Authority

1. This is a civil penalty proceeding pursuant to Section 309(g)(2)(A) of the Clean Water Act ("CWA"), 33 U.S.C. § 1319(g)(2)(A), and the *Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties, Issuance of Compliance or Corrective Action Orders and the Revocation, Termination or Suspension of Permits*, including Subpart I, published at 64 Fed. Reg. 40176 (July 23, 1999) and codified at 40 Code of Federal Regulations ("C.F.R.") Part 22.

2. The authority to take action under Section 309(g)(2)(A) of the CWA, 33 U.S.C. § 1319(g)(2)(A), is vested in the Administrator of the United States Environmental Protection Agency ("EPA"). The Administrator has delegated this authority to the Regional Administrator, Region 4, who in turn has delegated this authority to the Director of the Water Management Division, who in turn has delegated this authority to the Chief of the Water Programs Enforcement Branch of EPA Region 4 ("Complainant").

II. Allegations

3. At all times relevant to this action, Philpot Enterprises, LLC ("Respondent"), was a limited liability corporation duly organized and existing under the laws of the Commonwealth of Kentucky and therefore a "person" within the meaning of Section 502(5) of the CWA, 33 U.S.C. § 1362(5).

4. At all times relevant to this action, Respondent owned and/or operated a construction site known as Sherman Elementary School ("Development") located at 3095 Dixie Highway in Dry Ridge, Kentucky.

5. To accomplish the objective of the CWA, defined in Section 101(a) of the CWA, 33 U.S.C. § 1251(a), to restore and maintain the chemical, physical and biological integrity of the nation's waters, Section 301(a) of the CWA, 33 U.S.C. § 1311(a), prohibits the discharge of

pollutants by any person into waters of the United States except as in compliance with a National Pollutant Discharge Elimination System ("NPDES") permit issued pursuant to Section 402 of the CWA, 33 U.S.C. § 1342.

6. Section 402 of the CWA, 33 U.S.C. § 1342, establishes an NPDES Permit Program authorizing EPA or authorized states to administer the NPDES Permit Program, including the issuance of NPDES permits allowing for the discharge of pollutants, including storm water, into navigable waters subject to specific terms and conditions. EPA has granted the Commonwealth of Kentucky through the Department for Environmental Protection ("KDEP") approval to issue NPDES permits pursuant to Section 402(b) of the CWA. KDEP is responsible for the enforcement of Kentucky Revised Statutes ("KRS") Chapter 224 and 401 Kentucky Administrative Regulations ("KAR") 5:055, Sections 1 and 5, and the approval of permit coverage upon submission of a Notice of Intent ("NOI").

7. KDEP issued a *General KPDES Permit for Storm Water Point Source Discharges, Construction Activities* ("Permit"), Permit No. KYR10, in accordance with the provisions of the KRS Chapter 224 and pursuant to 401 KAR 5:055, Sections 1 and 5, and the CWA. The Permit was effective October 1, 2002, and expired September 30, 2007.

8. The Permit is a Kentucky statewide NPDES general permit governing storm water point source discharges associated with construction activities including clearing, grading, and excavation activities except operations that result in the disturbance of less than five (5) acres of total land area which are not part of a larger common plan of development or sale.

9. To obtain coverage under the Permit, a signed NOI must be submitted to KDEP forty-eight (48) hours before construction activity begins. Failure to obtain or maintain Permit coverage shall not relieve a discharger from complying with the applicable performance standards. 401 KAR 5:055, Section 1.

10. On March 10, 2007, Respondent submitted a Notice of Intent ("NOI") requesting permit coverage to KDEP.

11. Part II of the Permit incorporates 401 KAR 5:065, Section 1, by reference.

A. 401 KAR 5:065, Section 1(4), requires the Permittee to take all reasonable steps to minimize or prevent any discharge which has a reasonable likelihood of adversely affecting human health or the environment.

B. 401 KAR 5:065, Section 1(5), requires the Permittee to properly operate and maintain all facilities and systems of treatment and control and related appurtenances which are installed or used to achieve compliance with the conditions of the Permit.

12. Part IV of the Permit requires the Permittee to modify the Best Management Practices (“BMP”) Plan if it proves to be ineffective in controlling the discharge of pollutants, or when there is a change in the design, construction, operation or maintenance which has a significant effect on the potential for the discharge of pollutants to surface waters, and to implement such modifications within seven (7) days.

13. Part IV.A of the Permit requires the BMP Plan to include, *inter alia*: the order of major soil disturbing activities; the post construction runoff coefficient; receiving water name; and a site map indicating drainage patterns and approximate slopes after grading, areas of disturbance, the location of control measures, surface waters or wetlands, and storm water discharge locations.

14. Part IV.B.1 of the Permit requires the Permittee to preserve existing vegetation where possible and to stabilize all disturbed areas within fourteen (14) days on areas where construction activities have permanently or temporarily (for twenty-one (21) days or more) ceased.

15. Part IV.B.3 of the Permit requires the Permittee to install management devices during construction to control the pollutants in storm water discharges that will occur after construction has been completed. Velocity dissipation devices shall be placed at discharge locations and along the length of any outfall channel as necessary to provide a non-erosive flow so that the original physical and biological characteristics and functions of the receiving waters are maintained and protected. The installation of management devices may be subject to Section 404 of the CWA.

16. Part IV.C of the Permit requires the Permittee to minimize off-site vehicle sediment tracking and dust generation.

17. Part IV.F of the Permit requires the Permittee to keep inspection reports onsite as part of the BMP Plan.

18. Part IV.H of the Permit requires the Permittee to clearly identify all contractors or subcontractors who will implement each control measure identified in the BMP Plan, and have all contractors and subcontractors sign a certification statement.

19. On October 25, 2007, representatives of EPA in conjunction with KDEP performed a Compliance Storm Water Evaluation Inspection (“CSWEI”) at Respondent’s Development to evaluate the treatment and disposal of storm water in accordance with the CWA, the regulations promulgated thereunder at 40 C.F.R. § 122.26, and the KDEP Permit.

20. As a result of the CSWEI, EPA, Region 4 has determined that storm water associated with industrial activity was discharged from the Development within the meaning of Section 402(p) of the CWA, 33 U.S.C. § 1342(p), and its implementing regulations.

21. During the CSWEI, EPA inspectors observed the following:

A. Respondent failed to take all reasonable steps to minimize or prevent any discharge which has a reasonable likelihood of adversely affecting human health or the environment, as required by Part II of the Permit and 401 KAR 5:065, Section 1. Sediment was observed from outfall of the sedimentation pond to the creek.

B. Respondent failed to properly operate and maintain all facilities and systems of treatment and control and related appurtenances which are installed or used to achieve compliance, as required by Part II of the Permit and 401 KAR 5:065, Section 1(5). Three check dams on the back part of the Development were filled with sediment and at least one was breached; the two outfalls were not protected; and additional silt fencing was needed.

C. Respondent failed to modify the BMP Plan since it was ineffective in controlling the discharge of pollutants, and to implement such modifications within seven (7) days, as required by Part IV of the Permit. An outlet at the base of the sedimentation pond was allowing water to be discharged immediately without allowing solids to settle.

D. The BMP Plan did not contain the order of major soil disturbing activities, post construction runoff measures, receiving water name, and a site map indicating drainage patterns and approximate slopes after grading, areas of disturbance, the location of control measures, surface waters or wetlands, and storm water discharge locations, as required by Part IV.A of the Permit.

E. Respondent failed to preserve existing vegetation where possible, and to stabilize areas where construction had not occurred over the past twenty-one (21) days, as required by Part IV.B.1 of the Permit. Much of the Development lacked soil stabilization, and the banks of the sedimentation pond had also not been stabilized.

F. Respondent failed to install management devices such as velocity dissipation devices, at the discharge locations or in the outfall channels, as required by Part IV.B.3 of the Permit. There was no protection at the outfalls, and existing check dams were ineffective due to the need for sediment removal and maintenance/repair.

G. Respondent failed to minimize off-site vehicle sediment tracking and dust generation, as required by Part IV.C of the Permit. There was a lack of adequate gravel at the entrance/exit pad.

H. Respondent failed to keep inspection reports onsite as part of the BMP Plan, as required by Part IV.F of the Permit. There were no inspection records available for review during EPA's inspection.

I. Respondent failed to clearly identify all contractors or subcontractors who will implement each control measure identified in the BMP Plan, and have all contractors and subcontractors sign a certification statement, as required by Part IV.H of the Permit.

22. Therefore, Respondent has violated Sections 301 and 402(p) of the CWA, 33 U.S.C. §§ 1311 and 1342(p), by failing to comply with the Permit at its Development, and also for discharges not authorized by the Permit at its Development.

III. Stipulations and Findings

23. Complainant and Respondent have conferred for the purpose of settlement pursuant to 40 C.F.R. § 22.18 and desire to resolve this matter and settle the allegations described herein without a formal hearing. Therefore, without the taking of any evidence or testimony, the making of any argument, or the adjudication of any issue in this matter, and in accordance with 40 C.F.R. § 22.13(b), this Consent Agreement and Final Order ("CA/FO") will simultaneously commence and conclude this matter.

24. For the purposes of this CA/FO, Respondent admits the jurisdictional allegations set out above and neither admits nor denies the factual allegations set out above.

25. Respondent hereby waives its right to contest the allegations set out above and its right to appeal the Final Order accompanying this Consent Agreement.

26. Respondent consents to the assessment of and agrees to pay the civil penalty as set forth in this CA/FO and consents to the other conditions set forth in this CA/FO.

27. By signing this CA/FO, Respondent certifies that the information it has supplied concerning this matter was at the time of submission, and is, truthful, accurate, and complete for each such submission, response and statement. Respondent realizes that there are significant penalties for submitting false or misleading information, including the possibility of fines and/or imprisonment for knowing submission of such information.

28. EPA reserves the right to assess and collect any and all civil penalties for any violation described herein to the extent that any information or certification provided by Respondent was materially false or inaccurate at the time such information or certification was provided to EPA.

29. Complainant and Respondent agree to settle this matter by their execution of this CA/FO. The parties agree that the settlement of this matter is in the public interest and that this CA/FO is consistent with the applicable requirements of the CWA.

IV. Payment

30. Pursuant to Section 309(g)(2)(A) of the CWA, 33 U.S.C. § 1319(g)(2)(A), and 40 C.F.R. Part 19, and considering the nature of the violations and other relevant factors, EPA has determined that **Seven Thousand Five Hundred Dollars (\$7,500.00)** is an appropriate civil penalty to settle this action.

31. Respondent shall submit payment of the penalty specified in the preceding paragraph via cashier's or certified check, payable to the order of "Treasurer, United States of America." The check shall reference on its face the name of Respondent and the Docket Number of this CA/FO. Such payment shall be tendered to:

32. At the time of payment, Respondent shall send a separate copy of the check, and a written statement that payment has been made in accordance with this CA/FO, to the following persons at the following addresses:

33. The penalty amount specified herein shall represent civil penalties assessed by EPA and shall not be deductible for purposes of federal taxes.

34. Pursuant to 40 C.F.R. Part 13 and 31 U.S.C. § 3717 et seq., if EPA does not receive payment of the penalty assessed by this CA/FO in full by its due date, interest shall accrue on the unpaid balance from the due date through the date of payment at an annual rate equal to the rate of the current value of funds to the United States Treasury as prescribed and published by the Secretary of the Treasury. If all or part of the payment is overdue, EPA will assess a late-payment handling charge of \$15.00, with an additional delinquent notice charge of \$15.00 for each subsequent thirty (30) day period. EPA will also assess on a monthly basis an up to six percent (6%) per annum penalty on any principal amount not paid within ninety (90) days of the due date.

35. Pursuant to Section 309(g)(9) of the CWA, 33 U.S.C. § 1319(g)(9), failure by Respondent to pay the penalty assessed by the CA/FO in full by its due date may subject Respondent to a civil action to collect the assessed penalty plus interest (at currently prevailing rates from the effective date of this CA/FO), attorney's fees, costs for collection proceedings and a quarterly nonpayment penalty for each quarter during which such failure to pay persists. Such nonpayment penalty shall be in an amount equal to twenty percent (20%) of the aggregate amount of such penalty and nonpayment penalty which are unpaid as of the beginning of such quarter. In any such collection action, the validity, amount and appropriateness of the penalty and of this CA/FO shall not be subject to review.

V. General Provisions

36. This CA/FO shall not relieve Respondent of its obligation to comply with all applicable provisions of federal, state, or local law, nor shall it be construed to be a ruling on, or determination of, any issue related to any federal, state, or local permit. Other than as expressed herein, compliance with this CA/FO shall not be a defense to any actions subsequently commenced pursuant to federal laws and regulations administered by EPA.

37. Nothing in this CA/FO shall be construed as prohibiting, altering, or in any way limiting the ability of the United States to seek any other remedies or sanctions available by virtue of Respondent's violation of this CA/FO or of the statutes and regulations upon which this CA/FO is based, or for Respondent's violation of any federal or state statute, regulation or permit.

38. Except as otherwise set forth herein, this CA/FO constitutes a settlement by Complainant and Respondent of all claims for civil penalties pursuant to the CWA with respect to only those violations alleged in this CA/FO. Except as otherwise set forth herein, compliance with this CA/FO shall resolve the allegations of violations contained herein. Nothing in this CA/FO is intended to nor shall be construed to operate in any way to resolve any criminal liability of Respondent, or other liability resulting from violations that were not alleged in this CA/FO. Other than as expressed herein, Complainant does not waive any right to bring an enforcement action against Respondent for violation of any federal or state statute, regulation or permit, to initiate an action for imminent and substantial endangerment, or to pursue criminal enforcement.

39. Each undersigned representative of the parties to this CA/FO certifies that he or she is fully authorized to enter into the terms and conditions of this CA/FO and to execute and legally bind that party to it.

40. This CA/FO applies to and is binding upon Respondent and its officers, directors, employees, agents, successors and assigns.

41. Any change in the legal status of Respondent, including but not limited to any transfer of assets of real or personal property, shall not alter Respondent's responsibilities under this CA/FO.

42. Each party shall bear its own costs and attorneys fees in connection with the action resolved by this CA/FO.

43. In accordance with 40 C.F.R. § 22.5, the individuals below are authorized to receive service relating to this proceeding.



43. The effective date of this CA/FO shall be the date on which the CA/FO is filed with the Regional Hearing Clerk.




