Enclosed please find an executed copy of the Expedited Settlement Agreement (ESA) that resolves the Clean Air Act (CAA) matter (Docket No. CAA-04-2014-8015(b)) involving Buffalo Rock Company. The ESA was filed with the Regional Hearing Clerk, as required by 40 CFR Part 22 and became effective on the date of the filing.



EXPEDITED SETTLEMENT AGREEMENT

for violating 40 CFR § 68.65, 40 CFR § 68.95, and Section 112(r)(7) of the Clean Air Act.

This Expedited Settlement Agreement (ESA) is being entered into by the United States Environmental Protection Agency (EPA), Region 4, the Director of the Air, Pesticides and Toxics Management Division (Complainant), and by Buffalo Rock Company (Respondent), pursuant to Section 113(d) of the Clean Air Act (the "Act"), 42 U.S.C. § 7413(d), and pursuant to 40 CFR § 22.13(b).

ALLEGED VIOLATIONS

Based on a compliance monitoring inspection conducted at the Respondent's facility located at 111 Oxmoor Road, Birmingham, Alabama 35209, on December 9, 2013, EPA alleges that the Respondent violated the Act's Chemical Accident Prevention Program, when at the time of inspection, Respondent did not provide evidence that:

It documented that equipment complies with recognized and generally accepted good engineering practices as required by 40 CFR § 68.65(d)(2);

Its emergency response plan contains procedures for informing the public and local emergency response agencies about accidental releases as required by 40 CFR § 68.95(a)(1)(i);

Its emergency response plan contains procedures for the use of emergency response equipment and for its inspection, testing, and maintenance as required by 40 CFR § 68.95(a)(2);

It developed and implemented procedures to review, update, as appropriate, the emergency response plan to reflect changes at the stationary source and ensure that employees are informed of changes as required by 40 CFR § 68.95(a)(4).

SETTLEMENT

In consideration of Respondent's size, its full compliance history, its good faith effort to

comply, and other factors as justice may require, and upon consideration of the entire record the parties enter into the ESA in order to settle the violations cited above, for the total penalty amount of **\$4,950**.

This settlement is subject to the following terms and conditions: the Respondent by signing below admits the jurisdictional allegations contained herein, neither admits nor denies the specific factual allegations contained herein, and consents to the assessment of the penalty as stated above; Respondent waives its rights to a hearing afforded by Section 113(d)(2)(A) of the Act, 42 U.S.C § 7413(d)(2)(A), and to appeal this ESA or otherwise contest the allegations contained in this ESA; and each party to this action shall bear its own costs and fees, if any.

Respondent certifies, subject to civil and criminal penalties for making a false submission to the United States Government, that the Respondent has corrected the alleged violations listed in this ESA.

Within fifteen (15) days of receiving a copy of the fully executed ESA, Respondent shall pay a civil penalty in the amount of **\$4,950**. Respondent's payment shall be made by sending a cashier's check or certified check (payable to the "Treasurer, United States of America") in the amount of **\$4,950**, in payment of the full penalty amount to one of the following addresses:


