REPORT RECOMMENDING CONTINUATION  
OF ALTERNATIVE DISPUTE RESOLUTION PROCESS

The Chief Administrative Law Judge’s (“Chief Judge’s”) Order of November 18, 2014 provided that this alternative dispute resolution (“ADR”) process terminate on January 17, 2015. In a Report Recommending Continuation of Alternative Dispute Resolution Process, dated January 13, 2015, I recommended, and the Chief Judge approved, continuation of the ADR process, until February 17, 2015, since the parties expressed a desire to pursue further settlement discussions and negotiations were ongoing. Following a joint session on February 4, 2015, the parties successfully reached a settlement agreement in this matter. The parties, however, require additional time to file a fully executed Consent Agreement and Final Order (“CAFO”). Consequently, I recommend continuation of the ADR process for one final month, until March 16, 2015, to allow the parties sufficient time to file the CAFO in this case. The parties are commended for their success in negotiating settlement of this matter.
