## **ORDER SCHEDULING POST-HEARING SUBMISSIONS**

As indicated on the record at the conclusion of the hearing, the parties may file posthearing briefs. *See* 40 C.F.R. § 22.26 ("After the hearing, any party may file proposed findings of fact, conclusions of law, and a proposed order, together with briefs in support thereof."). Reply briefs may be filed if the parties deem it necessary. The post-hearing briefs shall be submitted pursuant to the following schedule:

<b>Respondent's Initial Post-hearing Brief</b>	Friday, January 20, 2023
Complainant's Reply Brief	Friday, February 3, 2023
<b>Respondent's Reply Brief</b>	Friday, February 17, 2023

All briefs shall contain specific citations to the record and to any legal authorities upon which the filing party relied. If a party does not intend to file an initial or reply post-hearing brief as permitted above, they shall notify Alyssa Katzenelson, an Attorney-Advisor for this Tribunal, at katzenelson.alyssa@epa.gov.

The parties are reminded that the pursuit of settlement in this matter is permissible while issuance of the written decision is pending.
