ORDER GRANTING MOTION TO EXTEND TIME TO RESPOND TO RESPONDENT'S MOTION FOR PARTIAL ACCELERATED DECISION

A Prehearing Order was issued in this matter on May 4, 2011. After Complainant filed a Motion for Stay, the undersigned extended prehearing filing deadlines. Complainant filed its Initial Prehearing Exchange on July 22, 2011. Respondent filed its Prehearing Exchange on August 12, 2011. Complainant's Rebuttal Prehearing Exchange is due on August 26, 2011.

On or about August 15, 2011, Respondent filed a Motion for an Accelerated Decision on the Penalty Factor for Gravity ("Respondent's AD Motion"). The procedural rules that govern this proceeding, 40 C.F.R. Part 22 ("Rules"), provide that a non-moving party may file a response to a motion within fifteen days from service of a motion. 40 C.F.R. § 22.16(b). However, the Presiding Officer "may set a shorter or longer time for response or reply . . ." Id.

Complainant filed a Motion to Extend Time to Respond to Respondent's Motion for Partial Accelerated Decision dated August 15, 2011 ("Motion"), wherein it seeks an extension of the deadline by which it must file a response to Respondent's AD Motion to September 6, 2011, because Complainant's counsel is out of the office during the week of August 22, 2011. Complainant notes in the Motion that Respondent does not oppose it.

The unopposed Motion is hereby GRANTED. Complainant shall file a response to Respondent's Motion for an Accelerated Decision on the Penalty Factor for Gravity on or before September 6, 2011.


