ORDER ON COMPLAINANT'S MOTION FOR EXTENSION OF TIME TO FILE PREHEARING EXCHANGE

Complainant filed a Motion for Extension of Time to File Prehearing Exchange ("Motion") on June 11, 2015. In the Motion, Complainant states that "[a]fter holding a day-long mediation session on June 5, 2015, EPA and Respondents have reached a settlement-in-principle," and "[a] thirty-day extension of the prehearing exchange deadlines will provide time for the Parties to complete, execute and file the [Consent Agreement and Final Order] (CAFO)." To date, no Respondent has submitted a response to the Complainant's Motion.

In accordance with 40 C.F.R. § 22.7(b), for good cause shown and after consideration of prejudice to other parties, the Request is hereby **GRANTED**. A fully-executed CAFO shall be filed by **July 20, 2015.** In the event that the parties do not file a fully-executed CAFO by that date, the parties shall file their prehearing exchanges pursuant to the following schedule:

July 20, 2015 Complainant's Prehearing Exchange

August 10, 2015 Respondent's Prehearing Exchange

August 31, 2015 Complainant's Rebuttal Prehearing Exchange
