Dear Ms. Bartow:

This submission is in response to the Generic Data Call-In (GDCI) Notice dated January 31, 2013, more specifically the submission of data to fulfill Guideline No. 850.2100.

For historical reference, below is a timeline of events regarding the GDCI:

- 4/29/2013 - AMVAC included or addressed the appropriate response and support documents requested to fulfill the initial 90 day response requirement.
- 8/7/2013 - EPA allowed AMVAC to complete the suggested 28-day Sub-Chronic Inhalation study to fulfill the 90-day Inhalation study (Guideline No. 870.3465).
- 9/23/2013 - EPA waived the Immunotoxicity requirement (Guideline No. 870.7800).
- 1/29/2014 - AMVAC submitted the 12 month response including several new and existing studies, additional justification and provided EPA a 12-month status update spreadsheet.
- 7/30/2014 – AMVAC received EPA letter and the HED science review dated July 7, 2014 titled “DCPA: HED Response to (12 Month) Comments on the Residue Chemistry Requirements of the Generic Data Call-In (GDCI-0798701-1140)” which accepted Guideline No. 860.1380 and rejected Guideline No. 860.1900.
- 7/31/2014 – The 7/30/2014 review also referenced an earlier HED review dated October 23, 2013 titled “DCPA: HED Response to Comments on the Residue Chemistry Requirements of the Generic Data Call-In (GDCI-0798701-1140)” which AMVAC had not yet received. As a result, AMVAC requested the referenced review from EPA and received it on July 31, 2014.
- 9/24/2014 - AMVAC responded to the EPA letter dated July 30, 2014, the October 2013 HED Review and the July 2014 HED review by providing justification to fulfill Guideline No. 860.1900 which should also allow acceptability of the waivers for the following guidelines: Guideline No. 860.1300, 860.1340, and 860.1480.

In regards to this submission, Margaret Hathaway requested a protocol and species via phone conversation on March 27, 2013. AMVAC submitted the 90-day response on April 29, 2013 which included the promise to generate the data and the protocol for EPA's review. On February 29, 2014 EPA asked if AMVAC would agree to use the HLS passerine acute approved protocol. AMVAC agreed in email on March 6, 2014 to use the protocol and requested an extension until October 30, 2014 to generate the data. Today AMVAC is submitting the data to fulfill the Acute Avian Oral study, Guideline No. 850.2100.
