## **ORDER FOR PARTIES TO FILE CLARIFYING STATEMENT**

As the parties have been notified, I am designated to preside over this proceeding. Upon my initial review of the pleadings, it is apparent that some clarification is needed as to the number of Respondents against which the Complainant has alleged violations.

Complainant identifies a single Respondent in the caption of the Complaint, as set forth above. Likewise, the body of the Complaint mirrors the caption and states that "Respondent is TWDS, Inc., a/k/a My Last Bath, Windows Direct of Cincinnati, d/b/a Windows Direct USA of Cincinnati, and Windows Direct, with its principal office located at 11258 Cornell Park Drive, Ste. 612, Cincinnati, Ohio 45242." Compl. ¶ 3. Counsel for Respondent(s) filed an Answer in this proceeding that admits the contents of Paragraph 3 of the Complaint. Answer ¶ 2. However, the Answer also refers to the names in the caption of the Complaint "collectively as Respondents" and provides "their" responses to the allegations in the Complaint.

Accordingly, the parties are **ORDERED** to confer and file a joint statement clarifying who the Respondent(s) in this proceeding is/are. If the parties disagree as to the number of respondents or their identity, they shall state their respective positions in the joint statement. The parties shall file their statement no later than **October 29, 2021**.
