**POST-HEARING SCHEDULING ORDER**

The hearing on penalty in this matter was held by videoconference on May 2-3, 2022. Any motion to conform the transcript to the actual testimony shall be filed on or before **June 24, 2022**. *See* 40 C.F.R. § 22.25. The parties may file this motion jointly or separately.

As provided for in the rules governing this proceeding, the parties “may file proposed findings of fact, conclusions of law, and a proposed order, together with briefs in support thereof.” 40 C.F.R. § 22.26. Therefore, the parties shall submit post-hearing briefs in sequential order, beginning with Complainant’s initial brief, in accordance with the following schedule:

Complainant’s Initial Post-Hearing Brief:	<b>July 8, 2022</b>
Respondent’s Initial Post-Hearing Brief:	<b>August 5, 2022</b>
Complainant’s Reply Post-Hearing Brief:	<b>August 19, 2022</b>
Respondent’s Reply Post-Hearing Brief:	<b>September 2, 2022</b>

All briefs shall contain specific citations to the record and to any legal authority the party wishes for this Tribunal to consider. *See* 40 C.F.R. § 22.26 (requiring all post-hearing submissions to contain adequate references to the record and authorities upon which the filing party relied).
