


STATUS REPORT

In accordance with the *Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties, Issuance of Compliance or Corrective Action Orders, and the Revocation/Termination or Suspension of Permits*, 40 C.F.R. Part 22, Complainant, the Director of the Land and Chemicals Division of the United States Environmental Protection Agency, Region III, hereby submits this Status Report.

At the request of Respondents, the depositions of Ismael G. Izuturk, Andrew Ma and Marie Owens Powell, scheduled to occur on November 19 and 20, 2014, were cancelled. In addition, also at the request of Respondents, the deposition of Adnan Kiriscioglu was rescheduled from November 18, 2014, to December 2, 2014, and again to December 18, 2014.
