JOINT STATUS REPORT

In its Prehearing Order of October 22, 2020, this Tribunal instructed the parties to file a Joint Status Report by November 20, 2020, in which the parties shall describe their "progress toward narrowing the remaining factual disputes for the Tribunal." *Id.*, at 2. Moreover, this Tribunal required that "[a]ny stipulations of fact upon which the parties have agreed shall be filed as a Joint Set of Stipulated Facts together with the Status Report." *Id.*

For the past two months, the parties have attempted to reach a stipulation of facts. The Respondent and the Complainant each prepared lengthy proposed stipulations, and then participated in good faith discussions with a goal of developing a robust set of stipulated facts. Unfortunately, the parties were unable to reach agreement on a set of stipulated facts that would narrow the facts in dispute. Nevertheless, these discussions were of use to the parties in better understanding the basis for each other's claims and planned defenses. Although the parties were unable to reach a stipulation at this time, it remains possible that the parties may agree to certain stipulations as this matter proceeds.

The parties are continuing to prepare for the pre-hearing exchanges as required by the October 22, 2020 Prehearing Order.
