In its August 6, 2024, Prehearing Order, this Tribunal ordered each party to file a preliminary statement no later than August 30, 2024. Complainant avers and answers this Tribunal's questions as follows:

- (1) Complainant requests the hearing in this matter to be held in person. Complainant is agreeable to holding any status conferences, hearings on motions, or other interim meetings virtually, assuming witnesses would not have to be called and evidence would not have to be presented during such meetings.
- (2) Complainant believes that the most appropriate location for the hearing in this matter is Minneapolis, Hennepin County, Minnesota. While Forest Lake, Washington County, Minnesota—the city in which Respondent resides and/or conducts its business—is located in a different county than Minneapolis, it is less than 30 miles from Minneapolis thus making it an easy commute for Respondent.
