**ORDER ON COMPLAINANT’S MOTION TO SET A BRIEFING SCHEDULE**

Pending before the Tribunal is Complainant’s Motion to Set a Briefing Schedule (“Motion”), filed May 24, 2021. In the Motion, Complainant asserts its intention to move for accelerated decision in this matter and asks for more time to file response and reply briefs than the rules governing this proceeding typically allow. Mot. at 1. As grounds for this additional time, Complainant cites Respondent’s pro se status and Complainant’s counsel’s plans to be out of the office, among other reasons. Mot. at 2.

Under the rules governing this proceeding, “[a] party’s response to any written motion must be filed within 15 days after service of such motion,” and “[t]he movant’s reply to any written response must be filed within 10 days after service of such response . . .” 40 C.F.R. § 22.16(b). However, I “may set a shorter or longer time for response or reply, or make other orders concerning the disposition of motions.” *Id.*

In this case, it is appropriate to set a briefing schedule for the reasons set forth by Complainant. Respondent has not filed a response to the Motion, but no response is needed. Accordingly, the Motion is **GRANTED**, and the following schedule shall apply to the submission of any motions for accelerated decision:

<b>June 23, 2021</b>	Motions for Accelerated Decision due
<b>July 23, 2021</b>	Response briefs to Motions for Accelerated Decision due
<b>August 6, 2021</b>	Reply briefs to Motions for Accelerated Decision due
