ORDER ON UNOPPOSED MOTION TO SUPPLEMENT

On September 13, 2018, the Agency filed a Motion to Supplement the Prehearing Exchange ("Motion"). In its supplement, the Agency submits an expert report prepared by its expert witness, Peter Stokely, and the curriculum vitae for its witness Delia Garcia. According to the Agency, Respondent does not oppose its Motion.

Under the rules governing this proceeding, a party is obligated to "promptly supplement or correct the [prehearing] exchanges when the party learns that the information exchanges or response provided is incomplete, inaccurate or outdated, and the additional or corrective information has not otherwise been disclosed to the other party pursuant to this section." 40 C.F.R. § 22.19(f). In this case, additional or corrective information is being disclosed by the Agency, and Respondent does not object to the inclusion of this information in the prehearing exchange. Consequently, the Agency's Motion is **GRANTED**.
