COMPLAINANT'S STATUS REPORT

The U.S. Environmental Protection Agency ("EPA" or "Complainant") filed a Complaint on December 18, 2024, against Jackson & Son Distributors, Inc., with an assumed business name of Jackson and Son Oil ("Respondent") alleging violations of the Clean Water Act. Respondent filed an Answer to the Complaint on January 17, 2025. On January 31, 2025, Complainant filed Proof of Service as required by 40 C.F.R. § 22.5(b)(1)(iii).

Most recently, on April 8, 2025, this Tribunal granted the parties' joint motion for a 60-day extension of the prehearing schedule. That Order requires the EPA to file a Status Report regarding the status of settlement discussions on or before May 23, 2025.

The EPA has previously filed status reports regarding settlement discussions on February 21, 2025, and March 24, 2025. In its March 24, 2025, status report, the EPA stated that it remains open to a further substantive response from the Respondent regarding settlement negotiations, and that Respondent had notified the EPA that it was preparing a substantive settlement response.

The EPA continues to be open to further settlement discussions. Since filing its March 24, 2025, status report, the EPA has not received a substantive response from the Respondent related to settlement negotiations.
