

ORDER EXTENDING TIME TO FILE ANSWER AND REQUEST HEARING

By motion filed with the Environmental Appeals Board on August 27, 2013,¹ Geason Enterprises, L.L.C., GE Ventures, L.P., Hammerhead Off-Road, Inc., and TJ Power Sports, L.L.C. (“Hammerhead Respondents”)² seek a 30-day extension of time to file an answer and request a hearing in the above-captioned matter.³ Motion for Extension of Time to Answer Complaint and Request Hearing (“Motion”). In support of the requested extension, the Motion states that “[t]he Complaint contains serious allegations that require substantial investigation by Hammerhead Respondents.” Motion at 2. The Motion represents that U.S. EPA’s Air Enforcement Division, the Complainant in this matter, does not oppose the requested extension.

³ Pursuant to 40 C.F.R. § 22.16(c), the Environmental Appeals Board “shall rule on all motions filed or made before an answer to the complaint is filed.”
