**ORDER GRANTING UNOPPOSED EXTENSION OF TIME**

By Motion dated September 16, 2016, the Complainant moved for a 60-day extension of time to submit a Consent Agreement and Final Order (CAFO) or otherwise engage in the prehearing process. As good cause the Complainant stated that the parties were actively engaged in constructive settlement discussions, which in part necessitated a determination by the State of Washington Department of ecology. The Motion further indicated that the relief sought was unopposed.

Therefore, for good cause shown, the Complainant’s Unopposed Motion for Extension of Time is hereby **GRANTED**, and the following new deadlines established: On or before **November 30, 2016**, the parties shall either submit their fully executed CAFO, with a copy served on the undersigned, *or both parties* shall file their respective Initial Prehearing Exchanges. The parties may each submit a rebuttal prehearing exchange on or before **December 15, 2016**.
