ORDER GRANTING UNOPPOSED MOTION FOR EXTENSION OF TIME TO FILE PREHEARING EXCHANGE

The Director of the Environmental Assessment and Innovation Division of U.S. Environmental Protection Agency Region 3 ("Complainant") initiated this proceeding on June 29, 2012, by filing Administrative Penalty Complaints and Notices of Opportunity to Request Hearing against Columbia Gas Transmission, LLC ("Respondent"), in Docket Nos. CWA-03-2012-0130 and CWA-03-2012-0078. The two dockets were consolidated on November 27, 2012. On February 5, 2013, the undersigned issued a Prehearing Order scheduling a series of prehearing filing deadlines. Pursuant to the Prehearing Order, Complainant's Initial Prehearing Exchange is due to be filed no later than March 1, 2013. On February 25, 2013, Complainant filed an Unopposed Motion for Extension of Time to File Pre-hearing Exchange ("Motion").

In its Motion, Complainant states that, as of January 25, 2013, the parties had reached a written agreement and were in the process of obtaining the signatures necessary to execute a Consent Agreement and Final Order ("CAFO"). Motion at 1. However, on or around February 7, 2013, it came "to the Complainant's attention that the Region had not provided the public notice and opportunity to comment as required by Section 309(g)(4)(A) of the Clean Water Act, 33 U.S.C. § 1319(g)(4)(A)." Complainant states that the public comment period will close on March 9, 2013, and that it expects to "file the CAFO no later than March 20, 2013." Motion at 2. Complainant therefore requests that the deadline to file its prehearing exchange be extended to March 20, 2013. Motion at 2. Complainant states "that Respondent does not oppose this [M]otion, subject to receiving a corresponding extension of time to file its prehearing exchange" Motion at 1.

The Rules applicable to this proceeding, 40 C.F.R. part 22, provide that "the Presiding Officer may grant an extension of time for filing any document: upon timely motion of a party to the proceeding, for good cause shown, and after consideration of prejudice to other parties; or upon its own initiative." 40 C.F.R. § 22.7(b). Agency policy supports the resolution of enforcement proceedings through voluntary settlement. See 40 C.F.R. § 22.18(b)(1). Because the parties have reached an agreement and reduced that agreement to writing, it is interest of judicial economy to allow the parties additional time to secure the signatures needed to ratify the

agreement and settle this matter. The Motion is unopposed, and there is no indication that granting Complainant's request will cause either party undue prejudice. For the foregoing reasons there is good cause to grant Complainant's request, and Complainant's Unopposed Motion for Extension of Time to File Pre-hearing Exchange is **GRANTED**. Unless a Consent Agreement and Final Order is filed first, the parties shall adhere to the following schedule for filing their prehearing exchanges:

March 20, 2013 Complainant's Initial Prehearing Exchange

April 12, 2013 Respondent's Prehearing Exchange

April 26, 2013 Complainant's Rebuttal Prehearing Exchange
