ORDER ON JOINT MOTION FOR WAIVER OF SERVICE REQUIREMENTS FOR COMPLAINT

Complainant, the Director of the Enforcement and Compliance Assurance Division of Region 10 of the United States Environmental Protection Agency (EPA), initiated this proceeding on January 25, 2024, by the filing of an administrative complaint (Complaint). Complainant alleges that Respondents, Candace Stuart-Stephens and Jerrod Stuart, have committed violations of the Clean Water and are therefore subject to payment of a civil penalty. *Id.* Complainant and Respondent have now filed a Joint Motion for Waiver of Service Requirements for Complaint (Joint Motion) and thereby requested that service of the Complaint be effective by electronic means rather than by one of the service methods prescribed in the Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties and the Revocation/Termination or Suspension of Permits, 40 C.F.R. Part 22.

So long as Respondents can be deemed to be aware of their legal right to insist on service of the Complaint in accordance with 40 C.F.R § 22.5(b)(1)(i), Respondents have the prerogative
