ORDER OF DESIGNATION

Administrative Law Judge M. Lisa Buschmann , U.S. Environmental Protection Agency, Washington, D.C., is hereby designated as the Administrative Law Judge to preside in this proceeding under Section 3008(a) of the Solid Waste Disposal Act, as amended, also known as the Resource Conservation And Recovery Act, 42 U.S.C. § 6928(a) and pursuant to the Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties and the Revocation or Suspension of Permits, 40 CFR Part 22.
