ORDER EXTENDING DEADLINES

By Prehearing Order issued January 22, 2013, Complainant was ordered to file a status report regarding the status of any settlement between the parties by February 15, 2013. If the parties did settle, they were ordered to file their fully-executed Consent Agreement and Final Order (“CAFO”) no later than March 1, 2013. The other deadlines set forth in the Prehearing Order were March 1, 2013, for Complainant’s Initial Prehearing Exchange, March 22, 2013, for Respondent’s Prehearing Exchange, and April 8, 2013, for Complainant’s Rebuttal Prehearing Exchange.

On February 13, 2013, Complainant filed a Status Report, stating that the parties have reached an agreement in principle. Therefore, Complainant requests an extension of time until March 29, 2013, to file a fully-executed CAFO, or alternatively, file its Initial Prehearing Exchange.

The procedural rules governing this proceeding, set forth at 40 C.F.R. part 22, authorize the undersigned to “grant an extension of time for filing any document: upon timely motion of a party to the proceeding, for good cause shown, and after consideration of prejudice to other parties; or upon its own initiative. 40 C.F.R. § 22.7(b).

In accordance with 40 C.F.R. § 22.7(b), for good cause shown and without prejudice to either settling party, Complainant’s request is hereby **GRANTED**. The deadlines set forth in the Prehearing Order issued in this matter on January 22, 2013, are hereby **REVISED** as set forth below:

March 29, 2013 CAFO or Complainant's Initial Prehearing Exchange
April 19, 2013 Respondent's Prehearing Exchange
May 3, 2013 Complainant's Rebuttal Prehearing Exchange

All other matters and requirements set forth in the Prehearing Order remain in effect.
