

REPORT RECOMMENDING TERMINATION
OF ALTERNATIVE DISPUTE RESOLUTION PROCESS
AND ASSIGNMENT OF A JUDGE FOR LITIGATION


The Order of October 31, 2014 provides that this alternative dispute resolution (ADR) process terminates November 28, 2014. The recommendation of this Report is that the ADR process be terminated, and that the case be assigned to a Judge for resolution through litigation.

The reason for this recommendation is that the parties, after three months of the ADR process, have not reached a settlement. Accordingly, the case should now be assigned to a Judge to preside over a litigated resolution of this case.

The parties did, however, successfully use the ADR process to negotiate the framework for a possible settlement. They are encouraged to continue their negotiations to try to reach a settlement. Finally, the undersigned expresses her appreciation to the parties for the courtesy and candor with which they participated in the ADR process.
