ORDER OF DESIGNATION

Chief Administrative Law Judge Susan L. Biro, Environmental Protection Agency, Washington, DC, is hereby designated as the Administrative Law Judge to preside in this proceeding under Section 309(g) of the Clean Water Act ("CWA"), 33 U.S.C. §1319(g) and in accordance with the Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties and the Revocation or Suspension of Permits 40 CFR Part 22.

Please note that pursuant to an official EPA pilot program, rather than filing all documents with the Regional Hearing Clerk as specified in 40 C.F.R. § 22.5(a), **all documents and correspondence filed in this matter shall be filed with the Headquarters Hearing Clerk** at the following address: Sybil Anderson, Headquarters Hearing Clerk, Office of Administrative Law Judges, 1200 Pennsylvania Avenue, N.W., Mail Code 1900R, Washington, D.C. 20460. Avenue, N.W., Washington, D.C. 20004. Documents filed by E-Mail should be sent to OALJfiling@epa.gov.¹


The Regional Hearing Clerk may properly reject any documents that a party attempts to file in the Regional Office while this matter is before the Administrative Law Judge.


