**MOTION FOR EXTENSION OF TIME TO FILE AN ANSWER AND  
REQUEST FOR HEARING**

Comes now Sloan Valve Company (Respondent), and moves for an extension of time until May 2, 2016, for Respondent to file an Answer and Request for Hearing, pursuant to Complainant's Procedures, 40 C.F.R. § 22.7(b). As good cause therefor, Respondent states the following:

On March 1, 2016, a copy of the Complaint was sent by United States Mail, Certified Mail, Return Receipt Requested, to Respondent. The Complaint was received by Sloan in Augusta on March 3, 2016. The Complaint is deemed admitted and a Default Order may be issued 30 days after receipt of the Complaint, unless a Request for Hearing and Answer is filed with the Regional Hearing Clerk for EPA Region 6. The Complaint contains numerous, complex allegations, four of the five counts allege "major" potential for harm and/or "major" deviations from regulatory requirements, and two of the five counts seek penalties for up to three years of violation. Many personnel are required to review the Complaint and provide information to answer the Complaint. Respondent is working diligently to conduct said investigation.




