**REPORT RECOMMENDING CONTINUATION  
OF ALTERNATIVE DISPUTE RESOLUTION PROCESS**

The Order by Chief Administrative Law Judge Biro, dated February 21, 2018, that initiated this alternative dispute resolution (“ADR”) process provides for a termination date of April 23, 2018. The recommendation of this Report is that the ADR process be continued for an additional 30 days, until May 23, 2018.

This continuation of the ADR process is recommended because the parties’ negotiations are ongoing. An initial joint conference was held on March 20, 2018, and a subsequent joint conference is scheduled to take place on April 25, 2018.
