REGIONAL HEARING CLERK U.S. ENVIRONMENTAL **COMPLAINANT'S RESPONSE IN OPPOSITION TO** PROTECTION AGENCY **RESPONDENT'S MOTION TO CONFORM TRANSCRIPT**

Pursuant to 40 C.F.R. §§ 22.16(b) and 22.25 of the Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties and the Revocation/ Termination or Suspension of Permits, the Director, Land and Chemicals Division, Region 5, United States Environmental Protection Agency ("Complainant") respectfully submits this Response in Opposition to Respondent's Motion to Conform Transcript.

In its motion, Respondent proposes two changes and contends that making these changes "will conform the transcript to the actual testimony presented at hearing." (Resp.'s Mot. at 2). Complainant respectfully disagrees.

Respondent proposes that the words "involve making" in page 158, line 22 of the transcript of Mr. John Hebert's testimony on February 8, 2012 be changed to "do not involve." This change is proposed to a question by Respondent's counsel to Mr. Hebert. The full question by Respondent's counsel to Mr. Hebert in which this change is proposed was transcribed as follows:

> Q. Those statements in the ECR involve making a determination as to whether claims made in that research bulletin are, quote, "substantially different," close quote; isn't that correct?

(2/8/12 Hebert Tr. at 158:22-25). The transcribed answer by Mr. Hebert is: "It looks like, yes, that's correct." (*Id.* at 159:1). Complainant has consulted with Mr. Hebert about this proposed change and Mr. Hebert recalls the question being asked as originally transcribed.

In addition, Respondent proposes that the word "didn't" be stricken from page 23, line 21 of the transcript of Ms. Claudia Niess's testimony. This change is proposed to the portion of the transcript containing Respondent's opening statement. The entire sentence in which this change is proposed was transcribed as follows: "So because the complainant can't show that the website didn't offer to sell Rozol, the complainant can't show that sale or distribution occurred for purposes of Counts 2,184 to 2,231, in addition to those earlier reasons I mentioned." (2/7/12 Niess Tr. at 23:20-24). Complainant cannot recall whether the word "didn't" was used in this sentence at this part of the hearing. Furthermore, removing the word "didn't" in this sentence would render the sentence grammatically incorrect.

For all of the foregoing reasons, Complainant respectfully requests that the Presiding Officer enter an order denying Respondent's Motion.


